On 25 April 2016 CREST held a Cyber Insurance Workshop at the CGI offices in London Kings Cross. We would like to take this opportunity to thank CGI for their hospitality. Attendees included CREST members, Insurance companies and insurance brokers who examined the question: How can the cyber insurance and incident response industries work more collaboratively? The workshop explored the security industry's lack of confidence in both the value of cyber insurance and the insurance companies and how to reduce both the likelihood of incidents and the claim value resulting from them. A set of actions was agreed by the two industries that aim to make a positive impact and move forward. A report has been drafted and will be available for download shortly.


